## 1. Program Overview

Massology's Corporate Massage Wellness Rewards™ program is a no-contract membership designed to provide organizations with ongoing benefits, exclusive rate reductions, and employee wellness perks.

The program is earned following the completion of three corporate massage events and is maintained through one annual event per membership cycle.

This packet outlines the program structure, benefits, eligibility, enrollment procedures, and employee instructions.



## 2. Complimentary Membership Benefits

Benefit	Description
<b>15% Discount On All Events</b>	The "Corporate Member" rate shown on your quotes is the rate your organization pays. It applies to all corporate massage events, for any department or location within our service areas. This discount is applied automatically to every quote, including events that already receive built-in rate reductions for longer durations.
<b>Employee Corporate Massage Perks™</b>	Corporate membership unlocks eligibility for all employees to enroll in the Employee Corporate Massage Perks™ program. This allows each employee to receive 10% off every personal in-home massage, shareable with anyone in their household.
<b>Complimentary Self-Scheduling Software</b>	<p>Corporate members receive access to Massology's self-scheduling system, allowing employees to register for one-time or ongoing onsite chair or table massage sessions without manual coordination from your team. This tool streamlines event planning and ensures smooth onsite operations.</p> <p>The system can:</p> <ul style="list-style-type: none"> <li>● Track participant counts</li> <li>● Allow staff to reserve specific time slots</li> <li>● Reduce administrative workload</li> <li>● Prevent overbookings</li> <li>● Provide HR with real-time visibility into event engagement</li> </ul>
<b>Priority Event Scheduling</b>	Corporate members receive priority access to peak scheduling windows, such as holidays, employee appreciation weeks, wellness fairs, and seasonal high-volume dates.
<b>Transferable membership</b>	Your company's membership is tied to the organization—not to a single individual. If the primary point of contact, department head, or event coordinator changes, the membership can be reassigned at any time. Simply notify Massology of the updated contact, and all benefits will continue seamlessly.

<p><b>Automatic Annual Membership Renewal</b></p>	<p><b>Your membership renews automatically each year as long as your organization completes one corporate massage event within the 12-month cycle.</b> There are no forms to submit, no renewal fees, and no administrative steps required. Once your annual event is completed, your benefits remain active for another full year.</p>
<p><b>Free To Join, No Maintenance Fees</b></p>	<p>There are no fees associated with joining, maintaining, or renewing the Corporate Massage Wellness Rewards™ program. You pay only for the corporate massage events you schedule. There are no setup charges, subscription fees, administrative costs, or hidden expenses. Your membership remains active solely through event activity, making it a cost-effective wellness benefit for companies of all sizes.</p>

## 3. How To Qualify For Rewards Membership

### Step 1

#### Host Three\* Corporate Massage Events

Your organization completes three\* full-price corporate massage events. Events may be any duration and may occur at any frequency.

**\*What counts toward the three events needed to qualify?**

We consider three separate corporate events as three qualifying projects. A single project may include multiple department visits or multi-location stops—for example, a wellness day held across several offices is still counted as one project or one event.

### Step 2

#### Membership Activation

After the third completed event, Massology activates the company's Corporate Massage Wellness Rewards™ membership. The benefits will begin from the day of enrollment. Our team will notify you of the enrollment into the program.

### Step 3

#### Automatic Annual Renewal

To maintain membership, your company must host at least one corporate massage event per year.

We'll send a reminder before your renewal date and review your annual activity.

If at least one event was completed in the previous year, your membership renews automatically.

### Step 4

#### Grace Period

If the annual event is not completed on time, a 30-day grace period is applied before the membership expires. Once expired, the organization must meet the full enrollment requirement again (three full-price events) to re-activate.

## 4. Wellness Rewards FAQ

### **\*What counts toward the three events needed to qualify?**

We consider three separate corporate events as three qualifying projects.

A single project may include multiple department visits or multi-location stops—for example, a wellness day held across several offices is still counted as one project.

To qualify, your company needs to complete three individual projects, each booked at our standard full-price rate.

### **How often can we schedule massage events?**

You may schedule events as often as needed. Monthly, quarterly, semi-annual, or annual bookings are all allowed.

### **Do longer events cost less?**

Yes. Longer events have built-in rate reductions, and members receive an additional 15% discount on top of the reduced rate.

### **What does the event rate include?**

Rates include your licensed therapist, all equipment, administrative support, event-related fees, and standard gratuity. Additional gratuity is optional.

### **Can we share Employee Corporate Massage Perks™ information with our staff?**

Yes. We encourage companies to share the program details with employees so they can take full advantage of their personal wellness benefits.

### **Can our membership be transferred to another coordinator?**

Yes. If your point of contact changes, we can transfer the membership upon request.

### **Does the membership apply to multiple office locations?**

Yes. Benefits apply to any qualifying location within Massology's service area.



## EMPLOYEE CORPORATE MASSAGE PERKS™ PROGRAM

Once the company is enrolled in the Corporate Massage Wellness Rewards™ program, all employees become eligible for personal wellness benefits through Massology's Employee Corporate Massage Perks™ program.

### 1. Employee Benefits

Benefit	Description
<b>10% Discount On All Mobile Massage Services</b>	Employees receive <b>10% off all personal in-home massage services</b> , including—but not limited to—single and multi-person sessions, medical massage, post-surgical lymphatic drainage, and private in-home events.
<b>Shareable Discount</b>	Employees may share their discount with anyone receiving services at the same home address, allowing family members or household guests to benefit from their membership.
<b>HSA/FSA Support</b>	Many services qualify for HSA/FSA reimbursement. Employees simply need a Letter of Medical Necessity, and we guide them through getting the required form from their healthcare provider.
<b>Unlimited Use During Membership Year</b>	Employees can use their discount as often as they'd like—no caps or limitations.
<b>Renewable Membership</b>	Employee memberships are valid for one year and must be renewed annually. If the company remains active in the Corporate Massage Wellness Rewards™ program, we will renew the employee's membership for another year.

## 2. How Employees Enroll

### Step 1

#### **Employees Enroll In Annual Membership**

### Step 1

#### **We Review and Approve Membership**

Massology will review the enrollment and add the membership to the employee account. The membership will automatically discount their services are check out.

### Step 1

#### **Get Discount On All Services**

Employee receives an automatic 10% in-cart discount on all bookings made on our website or through customer service.

### Step 1

#### **Employee Renews Membership**

Benefits remain active for one year. At expiration, the employee will be prompted to renew. We will review and renew the membership at no cost if the company maintains its Corporate Massage Wellness Rewards™ membership.

## 3. Employee Perks FAQ

### **What services are discounted?**

All personal in-home services are discounted, including single sessions, multi-person massages, medical massage, post-surgical MLD, spa services, private events, and spa parties. Discounts do not apply to products or membership purchases.

### **Can my household members use my discount?**

Yes. The employee membership discount is sharable with anyone receiving services at your home address.

### **Can I combine my discount with other promotions?**

No. Discounts cannot be combined unless a specific offer states otherwise.

### **How often can I receive a massage?**

As often as you'd like. There are no limits or caps on how many times you can use your discount during the membership year.

### **Does Massology accept HSA or FSA payments?**

Yes. Many services are eligible for HSA/FSA reimbursement.

You will need a Letter of Medical Necessity (LMN) from your healthcare provider. Massology assists employees in obtaining the necessary documentation to request this from their provider.

### **What types of in-home services do you offer?**

We offer a full range of in-home spa and medical massage services, including relaxation massage, deep tissue, medical massage, post-surgical MLD, multi-person sessions, private events, and spa parties.

### **Can I renew my employee perks if my company's corporate membership has expired?**

No. Employee perks cannot be renewed if your company is no longer active in the Corporate Massage Wellness Rewards™ program.

However, you may purchase a public two-year Massology Membership directly on our website if you wish to continue receiving member benefits.
